**INSTRUCTIONS TO CANDIDATES WHO WISH TO APPLY FOR
CHALLENGE REEVALUATION OF THEIR ANSWER BOOKS**

1. Every application for challenge reevaluation should be submitted by the candidate in the prescribed form along with the prescribed fee so as to be received by the Controller of Examinations through Principal within 07 days of the publication of the results of the concerned examination. Candidates are advised to send their applications only to Principal after getting recommendation from HoD.

2. The fee (fixed by Mahatma Gandhi University) should be paid as cash at **College Cash Counter Only** during counter hours and forwarded to the Controller of Examinations along with the application through Principal. Fees once paid will not be refunded.

3. Application form should contain original fee receipt, copy of hall ticket and copy of result sheet.

4. Applications which are late and not in the prescribed form and which are found defective in any respect will not be entertained and will be summarily rejected without notice.

5. ***In case of double valuation system, the Challenge Valuation mark will be awarded if there is a change of 15% of the maximum marks on reevaluation. If there is a change of less than 15%, the marks awarded initially will be the final marks.*** The fee will be refunded if the mark in the second valuation done jointly by two examiners is more than 15% of the maximum mark for the paper.

5.(a) In the case of applications which are found in order, the CE office will take steps to get the answer books revalued expeditiously so as to issue the result of reevaluation is quickly as possible.

(b) The results of challenge reevaluation will be communicated to the candidates concerned individually to the address furnished in their applications, as soon as the results are ready for issue. ***No interim enquiries of any kind will be entertained in this regard.***

(c) It may be noted that the CE office can never set in any case a time limit for the issue of the results of challenge reevaluation. The CE office will also therefore, not be liable for loss of any kind sustained by candidates concerned on account of the delay, if any, in issuing the results of challenge reevaluation.
